041/17: Election of Chairman and acceptance of office:

042/17 – Completion by all councillors of Acceptance of Office Forms

<u>044/17 – Consideration and Approval of the Schedule of Receipts and Payments for the</u> year ended 31.03.17

The Schedule of Receipts and Payments for the year ended 31.03.17 had been circulated by the Clerk and approved by the Internal Auditor.

After consideration of the Schedule, the Chairman **proposed** that the council accept and approves the Schedule as being a correct reflection of income and expenditure for the past year.

<u>045/17 – Consideration of quotation for renewal of insurance for 2017/2018 and the sufficiency of the cover offered.</u>

The Clerk had circulated the renewal quotation from the parish council's public liability insurance brokers, Came & Co. Three quotations had been obtained. The premium quoted by Came & Co. for 2017/2018 was £280 (last year was £273.75). Of the three quotations this one was the cheapest by a margin of £14. The cover offered was considered and deemed by the members as being sufficient for purpose.
